## MINUTES OF A COMMITTEE MEETING Held via ZOOM at 7.00PM TUESDAY 8<sup>th</sup> March 2022

1. **Welcome and Apologies** – Apologies received from Chris Bradley, Suzanne Sparrow, Peter Faulkner
2. **Minutes of meeting** 11 January 2022 were signed off. No matters arising
3. **Treasurer and Membership Secretary's Report**
  - Membership 310. Most outstanding subs had been collected.
  - Bank £3,926 of which:
    - £2,310 main account
    - £1,616 Court Woodland
  - We are still holding a £600 contribution £200 each from NNPC, Newton & Noss Network and SHDC towards the cost of Noss Voss to Creekside steps. The RYDA has also made a pledge to contribute £200 when the work has been completed, so our General Fund will be back to £1,510.
  - It was noted that HSBC bank, in line with other banks, has introduced a monthly fee to Charity Accounts. Decision made to keep RYDA subscription the same in spite of this.
4. **Planning Report.**
  - Land opposite Butts Park – Developer has been asked for more information from AONB
  - Collaton – It was expected that this application would appear at South Hams Development Committee later in March. However this has now been deferred to probably May, pending the development of a Planning Performance Agreement
  - Discussion on other recent applications
5. **Parking & Roads**

Committee is a Sub Committee of NNPC with PeterH from RYDA. Working exceedingly hard on people's concerns regarding parking and roads within the villages and endeavours looking very encouraging. Some discussion regarding the South Hams cleaning of the roadsides, which extends to Collaton as part of the Parish. Concern especially as this area is prone to flooding.
